NOVEMBER BUSINESS TRENDS VERSUS PRIOR YEAR	
CONSOLIDATED SALES +4% Consolidated sales increased +4% YOY for the month of November, +9% excluding the pass-through effect of lower natural gas prices, hurricane effects and an equipment sale in the prior year. Underlying sales growth reflects higher volumes and higher pricing in all geographic regions.	
NORTH AMERICA Sales -2% YOY, +6% ex-natural gas pass-through, hurricane effects and an equipment sale in the prior year. On-site oxygen volumes to the steel industry declined YOY and refinery hydrogen start-ups delayed by customers. Packaged gas volumes continue to be strong. Strong new business activity.	EUROPE Sales +18% YOY, +13% ex-currency. Higher sales driven by volume growth in Spain and Italy and higher overall pricing.
SOUTH AMERICA Sales +11% YOY, +9% ex-currency. Sales growth was driven by higher on-site, merchant and packaged gas volumes.	ASIA Sales +16% YOY, +12% ex-currency due to strong volume growth in China, India and Korea, primarily to metals and electronics markets. Strong new business development activity.
PST Sales -4% YOY, +10% ex-aviation repair divestiture. Continued strong demand for OEM aviation coatings. Volumes this month reflect equipment downtime for maintenance.
