



## A COMPELLING COMBINATION



### **WAITING PERIOD FOR PROPOSED BUSINESS COMBINATION BETWEEN PRAXAIR, INC. AND LINDE AG UNDER THE COMPETITION ACT (CANADA) EXPIRED, SATISFYING A CLOSING CONDITION**

**Guildford, U.K. (May 4, 2018)** – In accordance with the exchange offer document published on August 15, 2017, Linde plc announced today that the waiting period under the Competition Act (Canada) with respect to the proposed business combination between Praxair, Inc. (NYSE:PX) and Linde AG (Xetra:LIN) expired on May 3, 2018, satisfying a closing condition (Regulatory Condition – Canada). In accordance with the Competition Act (Canada), the Competition Bureau is continuing to review the proposed business combination, and the parties are assisting with that ongoing review.

Linde plc is a public limited company formed on April 18, 2017, that will become the parent company of Praxair, Inc. and Linde AG upon the completion of the business combination.

Completion of the business combination remains subject to the approval by requisite governmental regulators and authorities under applicable competition laws. The business combination is expected to be completed in the second half of 2018.
